Health Department of Northwest Michigan

NOTE: Health Department of Northwest Michigan case counts are reported on Mondays and Thursdays in the following format.

COVID-19 Case Counts

The Health Department of Northwest Michigan is reporting the following case information:

- On Thursday, Jan. 13, 211 new cases of COVID-19 were reported in Antrim (47), Charlevoix (83), Emmet (40), and Otsego (41), and one new COVID-19-related death in Otsego County.
- On Friday, Jan. 14, 154 new cases of COVID-19 were reported in Antrim (19), Charlevoix (33), Emmet (65), and Otsego (37).
- On Saturday, Jan. 15, 242 new cases of COVID-19 were reported in Antrim (38), Charlevoix (68), Emmet (91), and Otsego (45), and one new COVID-19-related death in Otsego County.
- On Sunday, Jan. 16, 40 new cases of COVID-19 were reported in Antrim (11), Charlevoix (10), Emmet (7), and Otsego (12).
- On Monday, Jan. 17, 247 new cases of COVID-19 were reported in Antrim (22), Charlevoix (59), Emmet (110), and Otsego (56), and one new COVID-19-related death in Antrim County.

As of 4 p.m. January 17, the cumulative case count information for the Health Department of Northwest Michigan is:

- Total COVID-19 confirmed and probable cases in the following counties: Antrim (3,654), Charlevoix (4,230), Emmet (5,437), and Otsego (4,784).
- Recovered COVID-19 cases in the following counties: Antrim (3,004), Charlevoix (3,210), Emmet (4,244), and Otsego (3,992).
- Confirmed COVID-19 associated deaths in the following counties: Antrim (51), Charlevoix (54), Emmet (65), and Otsego (88).

On January 14, the State of Michigan reported 1,746,707 cases and 28,479 deaths.
