Blood Lead Screening For Children

Lead poisoning is the number one environmental health threat to children in the U.S. Blood lead screenings are provided in WIC at 12 and 24 months of age, and at monthly clinics in Antrim, Charlevoix, Emmet and Otsego counties. Medicaid is accepted.

Breast and Cervical Cancer Control Navigation Program (BCCCNP)

BCCCNP provides free breast and cervical cancer screening for eligible women who are 40-64 years old. Services include a clinical breast exam, pap test, pelvic exam, HIV counseling and testing, and navigation.

Child and Adolescent Health Program

Clinics are available for youth in Mancelona (ages 5-21) and in Gaylord (ages 10-21) and their children. Nurse practitioners provide primary health care services – physical exams, treatment for illness and injuries, immunizations, and much more. Behavioral Health Therapists provide individual, family, and group counseling, and work with the Nurse Practitioner and the family. Charges are based on the youth's income, which means there may be no charge or a nominal fee.

Children's Healthcare Access Program (CHAP)

The Children's Healthcare Access Program (CHAP) is a care coordination partnership with local pediatric providers. CHAP provides resource coordination of community services with an emphasis on behavioral and oral health care via telephone consultation and/or home visit. CHAP also works with families to obtain transportation assistance in partnership with their health plan. CHAP serves children ages 0-17 who are assigned to one of the participating CHAP primary care providers.

Children's Special Health Care Services (CSHCS)

CSHCS is a program within the Michigan Department of Health and Human Services. This program is for children and some adults with special health care needs and their families. CSHCS helps persons with chronic health problems by providing coverage and referral for specialty services based on the person's health problems. CSHCS local staff provides family centered services and coordinated community services to assist families in caring for children at home.

Dental Health

Children and adults with Medicaid, Healthy Michigan Plan, Healthy Kids Dental (Delta Dental), and MICHild (Blue Cross or Delta Dental) may receive full dental services through the Health Department's dental clinics in Alpena, Cheboygan, East Jordan, Gaylord, Mancelona, Petoskey, Traverse City, and West Branch. The Northern Dental Plan offers dental services at a reduced fee.

Early Childhood Behavioral Health (ECBHI)

ECBHI enhances availability and access to behavioral health services for children 0-5 in Charlevoix, Emmet and northern Antrim counties. ECBHI provides education and support through Parent Support partner services, Ages and Stages Developmental Screenings, and Early Childhood Networking Nights.

Healthy Families Northern Michigan

Healthy Families is a free home visiting program that offers guidance, information, and support to help parents be ready for their baby's birth and raise a healthy family. Pregnant women and children up to age 4 may be eligible to receive home visits.

Hearing and Vision

A child's ability to see and hear greatly influences how they develop and how they learn about their world. Hearing screening is available to children ages 6 mos.-18 years; vision screening is available to children 3-18 years. Appointments are available in each county for free screening.

Home Care and Hospice

Home health and hospice services bring health care to people in their own homes as they recover from illness or injury, or health care and comfort at the end of life.

HUB Community Connections

The HUB Community Connections program serves Mancelona area teens and young adults ages 13-21. A Community Health Worker can help guide teens and their families through the healthcare and social services system, make referrals to helpful services, and make sure the family's needs are met with a supportive approach. There is no cost for this program.

Immunizations

All adults and children are welcome to receive vaccines to protect against polio, diphtheria, whooping cough, tetanus, measles, mumps, rubella, chickenpox, Shingles, hepatitis A, hepatitis B, haemophilus influenzae type B, meningitis, influenza, HPV, and pneumonia. Costs vary depending on insurance coverage and vaccines administered. Children less than 19 years of age may be eligible to receive VFC vaccines. Medicaid is accepted.

Maternal Infant Health Program (MIHP)

These programs assist families with pregnant women or young children by providing information on pregnancy, preparation for the baby, infant care, infant feeding, and parenting. Childbirth education classes and help with transportation costs are also available. Services are available to families with Medicaid and may be provided at the health department or in a family's home.

Medicaid Healthy Kids and MICHild, and Healthy Michigan Plan

Healthy Kids provides **free** health insurance coverage for pregnant women and children ages 0-19. The income allowance for Healthy Kids is higher for pregnant women and infants up to their 1st birthday. MICHild is health insurance coverage for uninsured children ages 0-19.

Michigan Colorectal Cancer Early Detection Program (MCRCEDP)

MCRCEDP provides colorectal cancer screening for eligible men and women 50-64 years of age. Services include an at home fecal occult blood test Fecal Immunochemical Test (FIT) and/or a colonoscopy at a local hospital (based on client history or positive Fecal Immunochemical Test).

Newborn Home Visits

Local hospitals and the Health Department are pleased to offer a home visit to every family with a new baby. Families can request the visit during their hospital stay, and a nurse will make a visit to weigh the baby, answer questions, provide information on caring for a new baby, and share information about community resources, such as playgroups.

School Wellness Programs

School Wellness Programs offer school nursing services and behavioral health counseling services to Pellston and Boyne City Public School students. The school nurse provides services such as nursing assessment and care, injury treatment, referral for primary care, and specialty health services and much more. The Behavioral Health Therapist provides individual, family, and group counseling. All services are free.

Sexual Health Services

Confidential clinic services are provided, including physical examination with birth control education and supplies, pre-conception and basic infertility counseling, pregnancy testing, STD evaluation and treatment, and health counseling. Services are covered under Medicaid and the Healthy Michigan Plan, or a sliding fee schedule is available.

WISEWOMAN and Wise Choices

These programs offer eligible individuals an opportunity to evaluate their cholesterol, blood sugar, blood pressure, and weight. Individuals receive assistance to make healthy lifestyle choices.

Women, Infants, and Children (WIC) Program

WIC provides free food to women who are pregnant and breastfeeding, and infants and children up to age 5. The food package is valued at over \$60.00 or more per month, and includes milk, eggs, cheese, cereal, fresh fruit and vegetables, juice, peanut butter, and infant formula. Medical, nutritional, and financial needs are reviewed to determine WIC eligibility. Immunizations, fluoride varnish, oral assessments, and blood leads are provided at WIC appointments. WIC also provides education and support for breastfeeding mothers, including one-on-one visits with a Certified Lactation Specialist.
